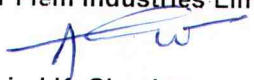

**1) Mr. J.K. Jain:**

Aged 68 years, Mr. J.K. Jain is founder promoter of the Company. As the Chairman & Managing Director of the Company, he is involved in mentoring the leadership team, advising on business strategies and in various aspects of the Company's expansion and diversification plans. He has more than four decades of experience in manufacturing of automotive lighting and signalling equipment and has played a significant role in growth and diversification of the Company. He has won many accolades and awards in India and overseas Including Life Time Achievement Award accorded by India International Council for Industries & Trade, National Achievement Award for Business Excellence presented by Indian Society for Industry & Intellectual Development and Outstanding Entrepreneurship Award accorded by Enterprise Asia.

**2) Mr. Rahul Jain:**

Aged 33 Years, he is the son of Mr. J.K. Jain and Mrs. Seema Jain and one of the promoters of the Company. He is on the Board since November, 2004 and as a Whole-time Director since October 1, 2012. He is involved in all strategic, corporate planning, operational, business development and OEM centric affairs of the Company.

**3) Mr. Kashi Ram Yadav:**

Aged 64 years, he has been associated with the Company since its inception and has more than 30 years' experience in production and manufacturing operations of automotive lightings, signalling equipment and rear view mirrors. He was appointed on the Board of Company in October, 2008. He is presently responsible for production and manufacturing operations in north India facilities of the Company.
