Godrej Group elevates 36-yr-old Pirojsha as realty arm chairman

Mumbai, Feb 2: Godrej Group on Thursday elevated Pirojsha Godrej, the son of group chairman Adi, as the executive chairman of the realty arm as the senior Godrej decided to step down from the post.

Adi Godrej, who will turn 76 in April, will continue as chairman emeritus at Godrej Properties, which earlier in the day reported a twofold jump in net profit at ₹77.25 crore, the company said in a statement.

On Wednesday, the 36-year-old Pirojsha was also nominated as a director on the board of Godrej Consumer Products, the flagship company of the group which is engaged in the fast-moving consumer goods market.

Pirojsha, who joined GPL in 2004, has been the managing director and CEO since 2012. Mohit Malhotra, currently the executive director, will now replace Pirojsha and assume charge of managing director and chief executive at Godrej Properties.

Malhotra, who joined Godrej Properties in 2010, and has been in business development and has since taken on larger leadership responsibilities that currently include heading GPL's operations. **PIT**
