सोमवार सुबह करीब साढ़े 11 बजे चोंगकिंग नगरपालिका के योंगचुआन जिले के लैसु शहर में निजी स्वामित्व वाली जिंशानगौ कोयला खान में विस्फोट हुआ था।

तब इसके अंदर कुल 35 खनिक काम कर रहे थे। विस्फोट के बाद दो मजदूरों को सुरक्षित बाहर निकाल लिया गया था जबकि 33 मजदूर गड्ढे में फंस गए थे। इसके बाद बचाव दल ने उन्हें बचाने की पूरी कोशिश की थी।

An email sent to Kodramantha was not answered. However, the Australian firm had earlier denied the allegation.

Lanco has so far paid about AUD 600 million and it was alleged that it is yet to pay about AUD 150 million to Kodramantha which is involved in a legal battle over the dues from the Indian firm.

Lanco alleged that Kodramantha misled the bidders by withholding two reports suggesting the Griffin coal deposits were smaller than disclosed first. According to the latest annual report of Lanco,

RJio to install 45,000 towers in six months

New Delhi, Nov 2: Telecom operator Reliance Jio Infocomm will install around 45,000 mobile towers in the next six months to boost its 4G network. "Reliance Jio in meeting with telecom minister (Manoj Sinha) has committed to invest 45,000 crore mobile towers in next 6 months to further strengthen its network. The company has said that it has plans to invest ₹1 lakh crore over a period of 4 years and the new towers are part of this investment," an official source told PTI.

No immediate comments were received from Reliance Jio Infocomm Limited (RJIL) on the matter. The source said that RJIL informed minister that it has already invested ₹1.6 lakh crore in the networks and installed 2.82 lakh base stations across the country.
