चीन ने मिसाइल परीक्षण को अमेरिका, दक्षिण कोरिया विवादों से जोड़ा

बेजिंग, 13 फरवरी (भाषा)।

चीन ने कहा कि वह अपने निकट साझेदार उत्तर कोरिया के हालिया बैलेस्टिक मिसाइल परीक्षण का विरोध करता है, लेकिन इस बात पर जोर दिया कि प्योंगयांग के इस कदम का ताल्लुक अमेरिका एवं दक्षिण कोरिया के साथ विवादों से है।

चीनी विदेश मंत्रालय के प्रवक्ता गेग शुआंग ने कहा कि चीन उत्तर कोरिया की ओर से किए गए बैलेस्टिक मिसाइल के परीक्षण-प्रक्षेपण का विरोध करता है और

उत्तर कोरिया ने किया बैलिस्टिक मिसाइल का परीक्षण

उसका यह कदम संयुक्त राष्ट्र सुरक्षा परिषद के प्रस्तावों का उल्लंघन भी है।

उन्होंने कहा कि चीन सभी संबंधित पक्षों का आह्वान करता है कि वे संयम दिखाएं और क्षेत्रीय स्थिरता को बरकरार रखें। प्रवक्ता ने कहा कि चीन सुरक्षा परिषद में संबंधित चर्चा में रचनात्मक और जिम्मेदार भूमिका निभाएगा ताकि उत्तर कोरिया के मिसाइल परीक्षण के जवाब को

अंतिम रूप दिया जा सके।

उत्तर कोरिया ने दावा किया कि उसने सतह से सतह पर मार करने में सक्षम मध्यम और लंबी दूरी की बैलेस्टिक मिसाइल पुकगुकसोंग-2 का सफल परीक्षण किया है। इससे पहले उत्तर कोरिया ने कहा कि उसने एक बैलिस्टिक मिसाइल का सफलतापूर्वक परीक्षण किया है। इसके बाद अमेरिका ने संयुक्त राष्ट्र सुरक्षा परिषद की तत्काल बैठक बुलाए जाने की अपील की है। इस प्रक्षेपण को अमेरिका के राष्ट्रपति डोनाल्ड ट्रंप के लिए एक चुनौती के रूप में देखा जा रहा है।
